#### WATERTOWN FARMERS MARKET GUIDELINES:

- There is WIFI on site. WIFI information will be given weekly from the Market Master.
- Items we allow to be sold at our Market: Farmers may sell produce and plant material for food, live ornamental plants, food and fiber derived from farm-raised animals for those purposes. All items must be CT grown and CT produced, owned or leased by a farmer. The farm must be located in CT and plants and animals must be raised in CT along with produce grown in CT.
- CT based vendors only will be admitted to the Watertown Farmers market.
- Artisans must only sell items they create at home or in a studio located in Connecticut. If goods sold consist of food items they must be labeled accordingly and follow health department guidelines. Health department certificates must be present/visible at your booth at all times. Breakdown: Soaps, clothing, scarves, natural home products, jewelry, photography, woodworking, eclectic works, furniture and so much more. If it's handmade <u>we would LOVE to consider it</u> for our Market. All artisan booths are at the discretion of the Watertown Parks & Recreation Department. We have a limited amount of artisan booths available weekly.
- Set up: Vendors can begin to set up at 3:00pm. Be ready to sell by 4:00pm and be packed up and out no later than 8:30pm, leaving your space exactly how you found it CLEAN. You must provide your own tables, chairs, tents/awnings.
- Vendor space is 10'x10'. If you need a double space, it will cost an additional fee for the season.
- Vehicles are NOT allowed on the park's lawn due to irrigation but your vehicle will be with you at all times for easy loading and unloading. Everything that comes onto your space must be taken away from your space at the end of each night. This includes any packaging materials.
- All tents must be securely anchored at all times (NO STAKES). You must use weights at least 10lbs each due to irrigation on the property. The Market does NOT supply weights so PLEASE be prepared or you will not be allowed to use your tent.
- There is absolutely NO SMOKING at the Market.

- Vendors are responsible to attend every week for full season vendor on the dates they chose. Vendors must contact the Market Master in advance (860) 945- 5246 or via email
  <u>wtnspecialevents@watertownct.org</u> if they are unable to participate on any given date. A vendor who has a planned event and can't make a week please contact us one week prior to the date.
- Vendors cannot share a space with other vendors if they are selling different items and have different business names.
- The market is open rain or shine. If we are in for severe weather (thunderstorms and heavy rain) the market will be closed for that day (per the town of Watertown Parks Department). If there is a cancelation, we will notify you before 2PM the date of the event.
- Watertown Parks & Recreation does not provide manpower for set up and break down.
- All insurance must be up to date including product liability. This is the vendor's responsibility to provide. The Watertown Parks & Recreation Departments Farmers Market and our Market Master assume no liability for loss or injury caused by products sold by any vendor at any time.
- This Market is geared for our community and families are a big part of that. We ask that you refrain from any profanities or abusive behavior for this will NOT be tolerated. Vendors who don't follow these rules will be asked to leave the Market and will lose their fee and space.
- The Market Master will act as the head contact for the duration of the Market. The Market Master will be the point of contact for all vendors. You will provide all necessary paperwork and fees to the market master. The Watertown Parks and Recreation Department is committed to creating a Market for everyone to enjoy and a place for vendors to come together and sell their goods. We want you to be successful that is our main goal.

**REFUND POLICY:** Refunds are granted automatically if an event is canceled. Refunds must be requested prior to the week before the program begins. On or after the event date no refunds will be granted unless unexpected medical complications (injury/illness) prohibit active participation in the event. A refund request form must be completed and submitted to the Parks & Recreation Department as soon as possible as refunds are not able to be issued before the form is received. The form is available at <u>www.watertownctrec.com</u> under general information, department info. A \$10.00 processing fee will be charged for all refunds; unless the Watertown Parks & Recreation is forced to cancel a program. Patrons must fill out a refund request form when they need to cancel out of a program. Patrons who submit a refund request form after the events registration has ended may be subject to a \$25 processing fee.
