PAYMENT POLICY: Payment, along with proper documentation, is due with registration for all events. We will accept cash, credit card (Master Card, Discover, Diner's Club, American Express, Visa, & debit cards), money order or check made out to "Watertown Parks & Recreation". No pre/postdated checks. A \$20.00 fee will be charged for any returned checks. Watertown Parks & Recreation Staff will not accept registration at the event site. Fees must be paid at the office prior to participation unless otherwise specified.

HARVEST CRUZE CAR SHOW MARKETPLACE GUIDELINES:

- **ELECTRICITY IS NOT PROVIDED.** Please be prepared with generators/other sources of power if necessary.
- This Market is geared for our community and families are a big part of that. We ask that you refrain from any profanities or abusive behavior for this will NOT be tolerated. Vendors who don't follow these rules will be asked to leave the Market and will lose their fee and space.
- Artisans must only sell items they create at home or in a studio located in Connecticut. If goods sold consist of food items they must be labeled accordingly and follow health department guidelines. Health department certificates must be present/visible at your booth at all times. Breakdown: Soaps, clothing, scarves, natural home products, jewelry, photography, woodworking, eclectic works, furniture and so much more. If it's handmade **we would LOVE to consider it** for our Market. All artisan booths are at the discretion of the Watertown Parks & Recreation Department. **We have a limited amount of artisan booths available.**
- Set up: Vendors can begin to set up at 8:00AM. Be ready to sell by 10:00AM and be packed up and out no later than 4:00PM, leaving your space exactly how you found it - CLEAN. You must provide your own tables, chairs, tents/awnings.
- Vendor space is 12'x12'. If you need a double space, it will cost an additional fee.
- Vehicles are NOT allowed on the lawn
- All insurance must be up to date including product liability. This is the vendor's responsibility to provide.
- Vendors are **NOT** to park in the main parking lot throughout the event. After unloading products, vendors are to move their cars to the back of the school for the duration of the event.
- No early tear downs unless it is an emergency.
- Please do not bring pets to the Harvest Cruze Car Show.

REFUND POLICY: Refunds are granted automatically if an event is canceled. Refunds must be requested prior to the week before the program begins. On or after the event date no refunds will be granted unless unexpected medical complications (injury/illness) prohibit active participation in the event. A refund request form must be completed and submitted to the Parks & Recreation Department as soon as possible as refunds are not able to be issued before the form is received. The form is available at www.watertownctrec.com under general information, department info. A \$10.00 processing fee will be charged for all refunds; unless the Watertown Parks & Recreation is forced to cancel a program. Patrons must fill out a refund request form when they need to cancel out of a program. Patrons who submit a refund request form after the events registration has ended may be subject to a \$25 processing fee.
